We the people of Milwaukee County are the victims of these crimes and have the right to have input into the sentencing of these defendants. Your statement, even if anonymous, is important to the court and us. Please complete the attached Community Impact Statement in this document and return within five days of sentencing. Always remember to include the name and case number on your statement.

Remember, these people have been charged with drug trafficking by the District Attorney's Office and are presumed to be innocent until proven guilty beyond a reasonable doubt in a court of law. ## District Attorney's Community Prosecution Unit

The Community Prosecution Unit is a community-based crime fighting initiative, working out of neighborhood offices and collaborating with others (including residents, community groups and other government agencies) in the development of problem-solving initiatives. Community prosecution is founded on the idea that prosecutors have a responsibility not only to prosecute cases but to solve public safety problems, prevent crime and improve public confidence in the justice system. In many cases, community stakeholders actually help to set the crime-fighting agenda and participate in the solutions. Definitions of success are changing as well. Rather than simply tallying cases won or jail sentences imposed, community prosecutors are measuring the effect of their work on neighborhood quality of life, community attitudes and crime.
