Crime affects the entire community. The following list provides details of the drug and firearms offenses currently being charged by the Milwaukee County District Attorney's Office.

As a resident of Milwaukee County and victim of an offense, you have the right to impact the sentencing of these defendants. Your anonymous statement provides valuable input to the court and community. Please complete the attached Community Impact Statement in this document and return within five days of sentencing. Always remember to include the offender name and case number on your statement.

Remember, these people have been charged with drug trafficking or firearms offenses by the District Attorney's Office and are presumed to be innocent until proven guilty beyond a reasonable doubt in a court of law. ## District Attorney's Community Prosecution Unit (CPU)

The Community Prosecution Unit is a community-based crime fighting initiative, working out of neighborhood offices and collaborating with others (including residents, community groups and other government agencies) in the development of problem-solving initiatives. Community prosecution is founded on the idea that prosecutors have a responsibility not only to prosecute cases but to solve public safety problems, prevent crime and improve public confidence in the justice system. In many cases, community stakeholders actually help to set the crime-fighting agenda and participate in the solutions. Definitions of success are changing as well. Rather than simply tallying cases won or jail sentences imposed, community prosecutors are measuring the effect of their work on neighborhood quality of life, community attitudes and crime.

# Safe & Sound Community Partners Program

Safe & Sound is a community-based, anti-crime strategy designed to reduce crime and violence. It utilizes the interdependent strategies of positive youth development at Safe Places, neighborhood organizing through the Community Partners, and tough law enforcement. It is a unique, collaborative approach to fighting crime, violence, illegal drug and alcohol sales, and other neighborhood problems. Safe & Sound's collaborating partners empower youth and adults to work together, creating a better, safer community for all.



Safe & Sound **Community Partners** are experienced organizers who help mobilize neighborhoods to reduce crime. Residents, parents, school or church groups, neighborhood block watches, and other individuals interested in developing ways to keep their neighborhoods safer, work with Community Partners to:

- Develop neighborhood block watches to reduce crime and increase neighborhood safety
- Promote conflict resolution and communication sharpening for better relationships with neighbors and City services
- Facilitate other neighborhood beautification and anti-crime efforts

Community Partners work closely with **Community Prosecution Unit Coordinators** to implement anti-crime initiatives tailored to each district's needs. CPU Coordinators utilize the real-time information and resident concerns regarding criminal nuisance issues. They leverage community relationships to solve problems and bring about long-term change:

- Work with residents to address problematic properties and individuals in respective districts
- Utilize Safe Places as a forum for youth engaged in creating safer communities
- Effectively maintain knowledge of the community and its resources, including community and faith-based organizations, employers, and block clubs
- Create and implement district anti-crime initiatives
- Assist law enforcement and Probation and Parole with reentry efforts for former offenders

Residents' input into the impact crime has on neighborhood quality of life is critical to achieving community restitution. The Community Partners Program is designed to connect residents to crime-reducing resources and give the community a voice; from reporting the first instance of a nuisance property or individual to impacting the sentencing of criminal activity in the neighborhood.
